What Is Employer Tuition Assistance?

Many organizations offer tuition assistance to their employees as a way to promote professional development. Students may qualify for tuition assistance depending on their employer and what the employer offers. The first place to look for this information is through your HR department and/or manager. You might also check your employee handbook. Ask what resources if any are available.

Questions To Ask Your Employer Tuition Provider:

- What is the exact dollar amount of tuition assistance that is awarded?
- What are the eligibility terms? (In other words, how do I qualify for available tuition assistance?)
- What is the timeline for receiving these benefits?

When receiving information from your employer, keep in mind the **annual limits vs. lifetime limits** on their provider's tuition assistance. You will also want to request employee eligibility documentation requirements.
